The inspector will also assess ancillary items including furniture, fencing, pathways, green areas and approaches.

Multi-use Sports areas will be inspected to BS EN 15312:2007 criteria and Wheeled Sports Facilities (skate parks) will be inspected to BS EN 14974:2006 criteria

Accompanied Annual Playground Inspection @ £71.00 per play area

As per the above inspection but gives you the opportunity to attend the inspection and see first hand the checks undertaken, it will also allow you to question the inspector regarding remedial advice or other related topics
